

# **PRIVACY POLICY**

## **ABOUT THIS PRIVACY POLICY**

North American Motor Car is committed to respecting and protecting your privacy. This privacy policy applies to every North American Motor Car website, event, app and other service (each, a "Service") that refers or links to this privacy policy. This privacy policy may be supplemented by additional privacy statements, terms or notices provided to you. The North American Motor Car company that owns or administers the Service, as identified therein, is the primary controller of your personal information provided to, or collected by or for, the Service.

#### INFORMATION WE COLLECT

We collect information about you in three ways: (1) from your input through our web forms, app forms and other mechanisms, (2) from third-party sources, and (3) through automated technologies.

#### **DATA YOU PROVIDE TO US**

The types of personal information that we collect directly from you depends on how you interact with us and the Service and may include:

- Contact details, such as your name, email address, postal address, social media handle and phone number;
- Account login credentials, such as usernames and passwords, password hints and similar security information;

# **DATA FROM SERVICE USE**

Our Service may automatically collect information about how you and your device interact with the Service, including:

 Computer, device and connection information, such as IP address, browser type and version, operating system, platform and other software installed on your device, unique device identifier and other technical identifiers, error reports and performance data; • Usage data, such as the features you used, the settings you selected, your URL click stream data, including date and time stamp and referring and exit pages, and pages you visited on the Service; and/or
